The City of Huntington has prepared its Five Year Consolidated Plan for the period of FY 2010 through FY 2014. The Consolidated Plan is a strategic document to implement Federal programs for housing, and community & economic development activities within the City of Huntington. The Consolidated Plan is a requirement of the U.S. Department of Housing and Urban Development (HUD) under the Community Development Block Grant (CDBG), Home Investment Partnership (HOME), and the Emergency Shelter Grant (ESG) programs. This Consolidated Plan covers the period beginning July 1, 2010 through June 30, 2015. In addition, the City has prepared its FY 2010 Annual Action Plan which documents the activities the City will fund for the coming year. The Five Year Consolidated Plan will be submitted to the U.S Department of Housing and Urban Development (HUD) on or before May 15, 2010.
